## Pactum Salutis

Before the Almighty God and under his Statutes, I declare that the foregoing is the truth in accord with the best of my knowledge

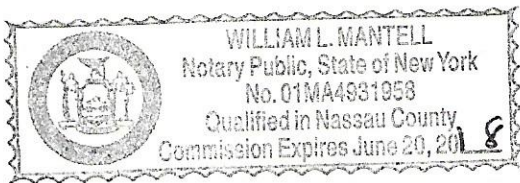
