DISCIPLINE NUMBER ONE

PURPOSE OF THIS RELIGIOUS SOCIETY

The purpose of this religious society is:

...to assemble together this Religious Society, as often as it pleases, for...."Whenever you may be coming together, each of you has a psalm, has a teaching, has a revelation, has a language, has a translation." 1 Cor. 14: 26. Let all occur to edification and consolation and comfort;

...to do those things which will promote the truth, the values, the teaching, and the Law of the Supreme Elohim (God) of all creation, YAHWEH, as exemplified by our Master and King Yahshua, (Jesus);

...to promote true liberty as can only be found in King Yahshua, to seek justice, to study the Scripture (in the Hebrew and the Greek), and to study the Natural Laws as given by YAHWEH, in

the Scriptures;

- ...to promote the comfort, the happiness, the spiritual life, as well as the physical well-being of Believers, utilizing Scriptural studies and research, and the study of law;
- ...to educate the community as to the Laws of YAHWEH, the laws of men, and to inform them of their valuable and certain inalienable rights, which are endowed and secured by YAHWEH to them, among which are Life, Liberty, and Property;
- ...to promote the development and the understanding of the Natural Laws and principles established by YAHWEH and to be involved in other acts and programs beneficial to the Society and to the community at large, and any other needful purposes as may be deemed necessary from time to time to effect their Freedom, Safety, and the Pursuit of Happiness, and rights;
- ...to the best of our ability, preserve, protect and defend the Constitution for the united States of America.

DISCIPLINE NUMBER TWO

STATEMENT OF FAITH

We Believe:

- ...that the Set-apart Scriptures of the Old and New Covenants, are the true recorded word of YAHWEH, given by His inspiration to Set-apart Men, and that it is an inerrant record in the original writings; that it is the written source for truth, faith, and conduct; that it contains the complete plan of YAHWEH for the salvation of His people Israel.
- ...that all translations of the Set-apart Scriptures contain some error. We believe in studying the Set-apart Scriptures in their original language in order to obtain the correct truth of the written word. We reject all teachings contrary to, those taught in the Set-Apart Scriptures.
- ...that the personal proper name for the One True Elohim of Israel, the Set-apart Christian people, is YAHWEH, or YAHVEH, from the Hebrew YHWH, as the Set-apart Scripture teaches. The Name YAHWEH is an expanded form of "YAH", that is derived from the Hebrew verb of existence HAWAH, (HAYAH) and means The Everlasting One, The I Am (He Who always was, Who is now, and Who always will be). Ex. 3:14,15; Ps. 68:4 and 83:16, 18. (in Hebrew).
- ...in One True Elohim, "Hear O Israel, YAHWEH our Elohim, YAHWEH is one", as the Scripture says in Deu. 6:4; therefore, "we believe there is none other Elohim but one". 1 Cor. 8:4;
- ...we believe in "one mediator between Elohim and men, the Man, Messiah Yahshua". 1 Tim. 2:5.; we believe that the Set-apart Spirit is the Spirit of YAHWEH, for Yahshua teaches us that "YAHWEH is Spirit". Jn 4:24.
- ...that we are sons of YAHWEH, for Scripture says, "for as many as are led by the Spirit of YAHWEH, are the sons of YAHWEH." Rom. 8:14, and are the temple of YAHWEH, for the Spirit of YAHWEH dwells in us. 1 Cor. 3:16.
- ...that all true and righteous believers who obey the Laws of YAHWEH, are true Israel, and the people of YAHWEH. "For this is the covenant that I will make with the house of Israel after those days, says YAHWEH; I will put my laws into their mind, and write them in their hearts: and I shall be their Elohim, and they shall be my people." Heb. 8:10; Jer. 31:33,
- ...in the possibility of the sinless life; that all true believers will have a heart-felt desire to worship YAHWEH; that His Spirit is making its home in each believer through union with the Spirit of Yahshua; that each believer will desire to fellowship with those who are likewise saved. These are the "true" Assembly of YAHWEH, these are all true Israel.
- ...that this religious society cannot be formed as a 501-C3 Corporation, because a 501 C-3

Corporation is a State created, controlled, and regulated entity. The Set-apart Assembly, or as the Greek says 'Ecclesia' (out calling) is a body of believers, formed under the sole control and headship of King Yahshua, and none other, 1 Cor. 11:3, "But now are they many members, yet but one body." 1 Cor. 12:20,

...that all Believers are called to be a witness, in life and in example, and will study the word to obtain truth through the indwelling power of YAHWEH'S Spirit, "rightly dividing the word of truth." II Tim. 2:15. "and always be ready to give an answer to everyone asking you a reason concerning the expectation that is in you, with meekness and fear," 1Pet. 3:15.

...in one Ecumenical (general, universal) creed, commonly called the Apostles' Creed, as a summary statement of Scriptural 'Christendom', stated as follows:

We believe in one Elohim the Father, Almighty,

Creator of heaven and earth. (whose proper name is YAHWEH)

And in Yahshua Messiah (Jesus Christ), His only begotten Son, our Master and King;

Who was conceived by the Set-apart Spirit, born of the virgin Mary;

Suffered under Pontius Pilate; was crucified, died, and was buried;

He decended into the grave.

The third day He was risen from the dead;

He ascended into heaven, and sits at the right hand of YAHWEH, the Father Almighty;

From there He is judging the living and those who have died.

We believe in the Set-apart Spirit of YAHWEH;

We believe in one Set-apart Universal Assembly (Ecclesia),

the communion of saints;

The forgiveness of sins:

The resurrection of a new body;

And of life into the ages. Amen

We also believe in the following Scriptural truths and mandates:

The gift of a new name;

The abandonment of any property associated with the number 666

To this end, that we may be true to the statement so well written by the Apostle Paul in his letter to the Philippians, "That you may be blameless and harmless, the sons of YAHWEH, without rebuke, in the midst of a crooked and perverse nation, among whom you shine as lights in the world." Phil. 2:15.

Praise YAHWEH our Elohim and Savior, and His Son Yahshua, our Master, Redeemer and King, His Son our brother.

DISCIPLINE NUMBER THREE

AUTHORITY OF THIS SOCIETY

This Assembly of YAHWEH, a Sovereign Family un-incorporated religious society, shall, for the purpose of this instrument, have the power to contract in the same manner and to the same extent as any other religious society, i.e. church, or Trust. It has the authority to buy, sell, and lease, and in every way deal in real and personal property in the same manner as a natural person. It has the authority as given to it by the Presiding Bishop (Trustee), in accordance with this instrument of discipline. The Bishop may appoint additional trustees to serve the society through his instructions, and in the capacity authorized by appointment letters for that purpose, signed by the Bishop. All appointments made by the Bishop shall have a termination date, or when not specified, all appointments shall terminate one year after the established date of the appointment. The society through the direction of the Bishop, may appoint legal counsel, licensed or unlicensed, but any professional or non-professional accounting, legal or other counsel employed shall be utilized in a capacity never greater than a subordinate co-counsel in any and all litigious matter whether local, national, or international, in order to protect the right of the society to address all tribunals, courts, hearings, meeting, assemblies and the like, as superior co-counsel.

All property of this society, personal, mixed, special, or real, shall be considered the "private property" of this Assembly, and shall be "held in trust" for the use, purpose, benefit, and advantage of this Assembly, a Sovereign Family un-incorporated religious society. The Presiding Bishop (Trustee) has sole authority for determining the disposal or use of all money, assets, or property. All contracts, agreements, obligations, donations, conditions, assets, money, property, and membership, shall be held in strict confidence by the Presiding Bishop and the members of this society. No disclosure will be made beyond the information published in this instrument of discipline, without the written permission of the Presiding Bishop. Membership in this Society is confidential and will not be disclosed.

DISCIPLINE NUMBER FOUR

VACANCY AND SUCCESSION

Any vacancy occurring in the office of the Presiding Bishop over/for this Assembly of YAHWEH, will be filled by an appointment according to the following descendency: Spousal, Birthright, Family appointment, Non-family appointment. Spousal, Birthright, and Family appointments are automatic appointments.

All Non-family appointments must be formally approved by the family members of the prior Presiding Bishop, in order for a Non-family member to be appointed Bishop successor. All such appointments shall be made with the spiritual support and the blessings of the clerical staff, and the General Assembly.

In witness whereof, the Presiding Bishop over/for the Temple of Light & Life, a Sovereign Family un-incorporated religious society has adopted the forgoing instrument, and has

hereunto set his seal, on this 5th day of May, in the year of our Master

Any Government Identifier Number (GIN) attached to this religious society, will, and is to be used for clerical purposes only, and neither establishes jurisdiction of, nor in any way demeans, subjugates or creates a fealty by the State over this Sovereign lawful religious entity, an unincorporated religious society, which is and perpetually remains Sovereign.
